Indiana's state task force continues to work towards state recognition for the Music Therapy profession. The Christel DeHaan Fine Arts Center is an educational arts facility located at the entrance of the campus on the corner of Hanna Avenue and Shelby Street.

From the north: Take I 65, I69, or Hwy 31 south towards Indianapolis. When you reach 465 in Indianapolis, take 465 East/South towards exit 2A (N East St). Once you have merged onto East St., Turn right onto E Hanna Ave. There is free parking on the corner of Hanna Ave and Shelby St, right next to the Fine Arts Center.

From the south: Take I 69 north towards Bloomington/Indianapolis. I 69 becomes IN-37. When you reach Indianapolis, merge onto 465 East towards IN-37 north. Take exit 2A towards N East St. Once you have merged onto East St., Turn right onto E Hanna Ave. There is free parking on the corner of Hanna Ave and Shelby St, right next to the Fine Arts Center.

From the east: Take I 70 West towards Indianapolis. Then, merge onto 465 South. Take exit 2A towards N East St. Once you have merged onto East St., Turn right onto E Hanna Ave. There is free parking on the corner of Hanna Ave and Shelby St, right next to the Fine Arts Center.

From the west: Take either I 70 or I 74 East towards Indianapolis. Merge onto 465 South/East. Take exit 2A towards N East St. Once you have merged onto East St., Turn right onto E Hanna Ave. There is free parking on the corner of Hanna Ave and Shelby St, right next to the Fine Arts Center.
